RELEASE AND INDEMNITY AGREEMENT

THE UNDERSIGNED does hereby represent and acknowledge that he is embarking upon a missionary venture with Carpenters for Christ of the Glen Baptist Church, Glen St. Mary, Florida; that the undersigned is engaging in a joint venture with the said other improvements for the glory of God and for the benefit of Open Bible Baptist Church, Chatham, VA that the work will at times be somewhat hazardous and will be performed by laymen unaccustomed to such work.; that some vehicles transporting said Carpenters for Christ will be operating by non-professional volunteers;

RECOGNIZING AND ACKNOWLEDGING the potential motor vehicle accidents and on-the-job construction site accidents in and about the living and eating quarters and during other activities for the Carpenters for Christ; the undersigned being fully aware of the said potential accidents and injuries to himself and other members of the Carpenters for Christ, desires to protect, release, acquit, indemnify and hold harmless the Carpenters for Christ, Open Bible Baptist Church, Chatham, VA and its representatives, and the Glen Baptist Church, Glen St. Mary, Florida, from any claims, injuries, damages, losses, expenses, or attorney’s fees incurred by myself, my heirs, administrators, executors, or assigns;

THE UNDERSIGNED for and on behalf of himself, his heirs, administrators, executors and assigns and all other persons, firms or corporations, does hereby release, discharge, and relieve from liability the Carpenters for Christ, Open Bible Baptist Church, Chatham, VA and its representatives, and Glen Baptist Church, Glen St. Mary, Florida; its successors or assigns, from any and all claims, demands damages, actions, caused, on account of, or any way growing out of injuries or damages both to person and property resulting, or that may hereafter result from the missionary trip of the Carpenters for Christ to Open Bible Baptist Church, Chatham, VA or any other place which is planned for June 10-17, 2022.

THE UNDERSIGNED, or his natural parents or legal guardian, if he be a minor, does hereby bind himself/themselves, his heirs, administrators, executors and assigns to repay to the said Carpenters for Christ, Open Bible Baptist Church, Chatham, VA and its representatives, the Florida State Baptist Convention and Glen Baptist Church, Glen St. Mary, Florida, any sum of money it or they may hereafter be compelled to pay because of any injuries or damages sustained by the undersigned as described above. The undersigned agrees to protect, defend, and indemnify said Carpenters for Christ, Open Bible Baptist Church, Chatham, VA and its representatives, the Florida State Baptist Convention and the Glen Baptist Church, Glen St. Mary, Florida, from any damages, expenses, attorney’s fees, losses or claims, suffered by said church parties because of any above described injuries or damages to the undersigned.

THIS WAIVER, RELEASE, AND INDEMNITY agreement is fully understood by the undersigned and he enters the same willfully for the purpose herein above stated.
